Dear Valued Stakeholder and Employers

As business grapples to get grips with the impact that the COVID-19 pandemic is having on markets and Industry we are also having to adapt to working in very different circumstances and surroundings. Our business continuity plans have been put to the test and have stood up well to date. With the challenges of the COVID-19 global pandemic and the increasing barriers posed by the lockdown, **the FP&M SETA Board and Management has approved the extension deadline for all Mandatory and Discretionary Applications on the FP&M SETA electronic indicium system to 12:00 midnight on 31st May 2020.** This means that all FP&M SETA stakeholders and employers can submit their WSP/ATR and/or Discretionary Grant Application on or before the 31st May 2020 midnight. The implication of this is that stakeholders and employers will no longer be required to apply individually for extension. Whilst this provides relief for employers under the current circumstances, employers are encouraged not to leave their submissions too close to the due date as there will be no other extension provided beyond the 31 May 2020.

We wish all our stakeholders to be safe, stay at home, but please make your submission by 31st May 2020. No further extensions will be considered for mandatory and discretionary grant applications for the 2020/21 scheme year. The FP&M Seta staff is available remotely to continuously assist those stakeholders wanting to access and create their WSP/ATR and DG applications for 2020-21.
